The list of factories scheduled to be inspected, which has been prepared on the basis of **"Computerized Risk Assessment"** and the frequency of inspections will also be available in the Directorate's portal.

However special visits to address specific issues like visit for investigation into complaints, accidents/dangerous occurrences, compliance of RTPS Act 2013 shall be carried out as per requirement under current practice.

In case a date of visit for routine inspection clashes with a date of compulsory visit for court attendance the schedule for court attendance shall prevail.
